

**UNACCOMPANIED MINORS** – When underage children travel internationally without one or both parents, **the child must travel with a notarized letter from their UNACCOMPANYING parents.** Date and sign the notarized letter as close to departure date as possible (recommend within 2 weeks of travel). **If both parents are not traveling, BOTH PARENTS must sign the letter.**

If either parent is deceased, the child is required to travel with a copy of the parent's death certificate. If only one parent has parental rights, the child is required to travel with a copy of the court order showing this. Include this information in the letter if applicable.

**WE RECOMMEND YOU TRAVEL WITH A COPY OF THE UNACCOMPANYING PARENT(S)' GOVERNMENT ISSUED ID (passport, driver's license). CHILD MUST TRAVEL WITH PASSPORT, and we recommend also traveling with a certified copy of Child's birth certificate which shows child's parents. SOME COUNTRIES REQUIRE A CERTIFIED COPY OF CHILD'S BIRTH CERTIFICATE.**
